Assistance

Breakdown assistance	Arranging and coordinating help in emergencies, plus coverage of costs; includes breakdown assistance (with replacement of small parts), towing, use of a courtesy car for the duration of the repair, salvage costs, accommodations, return and further travel. Coverage applies in the European countries appearing in green on the map
Travel insurance	Arranging and coordinating help in emergencies, plus coverage of costs; includes search, rescue and transportation costs, extra return travel, visit, accommodation and meal expenses.
Costs of annulment	Assumption of legal/contractual costs of annulment and incurred expenses for unused services in case of an insured event (e.g. illness, accident or death affecting you or an individual close to you, strikes, natural disasters, epidemics and other events in accordance with the GCI).
Substitute travel	Reimbursement of expenses incurred for booked travel and accommodation in the event of repatriation for medical reasons organized by an emergency call control unit due to a serious illness or accident.
Home Care Service	Coordinating immediate emergency response plus coverage of costs (in cases of fire, weather, theft, water or glass damage) for incidents occurring in the home or at a vacation property in Switzerland, the Principality of Liechtenstein, or the enclaves of Büsingen and Campione.

Legal expenses insurance for travel abroad	Assertion of non-contractual claims for damages and administration of legal interests for traffic and sporting accidents, attacks, robbery and theft. Coverage applies outside of Switzerland and the Principality of Liechtenstein.
Personal legal expenses insurance in CH and Liechtenstein or Europe	Assistance with litigation in your capacity as a private individual (concerning labor law, tenant law, contracts, etc.). Assertion of claims. Coverage of trial, expert witness and lawyer's fees.
Legal expenses insurance for travel in CH and Liechtenstein or Europe	Assistance with traffic-related litigation in your capacity as an owner, keeper or driver of a motor vehicle. Assertion of claims for damages and representation in criminal proceedings before public authorities and in court.
